ENROLLMENT – DHS is currently at 470 students enrolled.

ENROLLMENT APPLICATIONS FOR 2023-24 – All of the students who applied during the primary application period were given a personal welcome phone call from DHS students. The calls were followed up by an email welcoming them and giving them the acceptance form. Parents are calling in to schedule their orientation/registration meetings between April 3rd and 14th.

The Secondary application period will run from February 17th to March 17th.

ACCREDITATION: Our final online meeting with Dr. Brisbane-Stone will be on Monday, March 27th at 10AM. This will be a Zoom call with myself and Dr. Brisbane-Stone.

**DAILY LIFE AT DHS –
ACADEMICS:**

- Celina Sanchez won the regional American Legion Oratorical Contest and placed 4th at the state competition this past weekend in Orlando.
- DHS has launched the Net Support program which enables teachers to monitor what students are doing on their computers. This helps to be sure students are engaged in the activities they should be.
- Captain Parker and the fishing students exceeded their goal of \$10,000 at their fundraiser for reefs at Half- Hitch on Saturday, 2/25.
- Senior winter athletes were recognized at the morning assembly on February 28, 2023.
- The Senior Class Committee has been working tirelessly on great events for the Class of 2023.

ACTIVITIES/ARTS:

- The band and chorus will participate in their first Music Performance Assessments (MPA). Band will be Saturday, March 4th and Chorus will be Tuesday, March 7th; The students have been working extensively for these first performances at the district level and the students are ready to make their mark in history.
- Mrs. Tucker will be taking 5 students to compete at the FBLA State Conference on March 24-27, 2023.
- After a successful collaborative mural with Fudpucker's (images attached), the Destin High School visual art program currently has two mural projects in the works with a third on the way. The Eye Gallery in Destin Commons has just approved a digitally painted design which will be installed in one of their display cases. The art department has also been in collaboration with Mrs. Tucker's Leadership class to create a community mural for the new Captain Royal Melvin Heritage Park at 206 Hwy 98. Their most recent request has been to paint a fence for the Community Garden located behind the American Legion on Main Street.
- Since the opening of Destin High School, the visual arts department has enjoyed a successful history in local art competition. Students have repeatedly placed first in multiple categories and have won thousands of dollars in scholarships, awards, and sales. Our students have artwork printed on public banners, placed at the annual Congressional art competition with artwork displayed in Florida's First District Congressional Offices, and won three of the five winning places at the 2022 Destin for Success scholarship competition (image attached). We are immensely proud of our artists and look forward to seeing what they accomplish in the coming year.

It has been a very hectic time for Destin High Athletics as we are in full swing with spring sports, facility improvements, fundraising, banquets, and scheduling for next year's fall sports. Currently we have all spring sports active in competition season.

Baseball won its first preseason game and has been playing very competitively in all games to date. Price Bowen, has hit the first ever Home Run in school history, and the team will play this Thursday at West Florida High at 6:30pm. We are scheduled to play our first Home Game of the season on March 6, at Destin Elementary School vs. Choctaw High at 6:30pm. Softball has played well to date losing a very close game to Central High School 9-8 last Friday. They play tomorrow vs. Rutherford High School at 6:00pm at Morgan Sports Complex.

Boys and Girls Track are off to a strong start with impressive performances at the Viking Invitational, and the Viking Relays last Saturday. The sprinters on both teams are strong with our field events improving. Next meet for both teams is March 11 at the Seahawk Invitational at South Walton High School.

Boys and Girls Tennis started with a win vs. Jay High School in their opening match of the season. The boys defeated Jay 5-2, and the Girls defeated the Jay Girls 6-1. The next match for both teams is tomorrow at Crestview High School.

Boys Weightlifting is back in competition tomorrow at Baker High School at 3:00pm. Practices in our own weight room started for the first time this week and will give the team a chance to improve quickly this season.

Boys Lacrosse has shown tremendous grit and improvement against some of the best programs in the panhandle in their first four games. They will play again on March 17, vs. Navarre High School at the Destin Middle School Stadium. This is

one of the fastest growing sports in our area and we look forward to a strong finish.

Girls Beach Volleyball opened their season last Friday with a loss to South Walton High School. Coach Matt Means and the team will play Godby High School this Friday at 3:30pm on the campus of Florida A & M University.

Girls Flag Football opened their season at Niceville High last night and will be back in action this Thursday, March 2 at Crestview High School. This year's turnout was strong enough to have both a JV, and Varsity program. We welcome Kyle Bryant, as our Head JV Girls Flag Football Coach!

On February 16th, the Athletic Boosters held the first ever Destin High Athletics Celebrity Luncheon at the Edge Seafood Restaurant and Bar. Two sold out sessions of 72 patrons were served great food, listened to Tommy Bowden, former Clemson Head Football Coach, bought raffle tickets for great prizes, and were served lunch by Celebrities. Mel Ponder won the prize for the most money raised as a server. Those who attended were also given the opportunity for pictures with servers throughout the event. Special thanks to Heather, and Chris Thomas, and the Edge Restaurant for hosting, and preparing the food for the event. We were able to raise a total of \$15,575.60, and after expenses we deposited \$12,876.01 in the Athletics General account for athletic operations. Our next Athletic Department Fundraiser will be on April 30, 2023 as we provide the 2nd Annual Destin High Athletics Golf Tournament at Rocky Bayou Golf Club.

As of today, we have completed except for two small items our Destin High Strength and Conditioning Room. Life Fitness has delivered all of the equipment ordered and we are using the room daily, 7 periods of class and sports teams before, and after school. It is a one of a kind room for a high school and a definite showcase for Destin High, and our Athletic Teams. A special thanks again to Tripp Tolbert, for providing the donation of \$250,000 to finish the room with flooring and equipment. A special thanks to Sherwin Williams for donating the paint, and painting the room. We would like to suggest to the Destin High School Board that the process to name the room the "Tripp Tolbert Uptoit Strength and Conditioning Room," be considered for his generous donation of \$1,000,000.00 over the next four years for the development of Athletic Facilities.

Finally as of today, February 28, 2023 Athletics has brought in a total of \$289,208 since May 1, 2022 to help fund Athletic spending in all sports. Added to this amount is the \$80,000.00 that was the agreed upon amount with Red Apple Finance for Athletics Operations in last year's budget meeting with Steve, and Jeff. That totals what we have been operating from as an amount of \$369,208.00 for the 2022-23 school year. To date money paid out or owed totals \$344,399.00. This leaves Athletics with a balance of \$24,809.00 for operations before our annual golf outing, and sport team fundraisers to finish the school year. All documentation, and details can be given on request.

3. Exterior Fencing “perimeter” options were briefly discussed. Dusty met with SRO and Gary Venuti with the Okaloosa County School District Safe Schools Office. Went over several different options. Regardless of the options, fencing will have to be installed in certain areas. The 8’ fence on the side of the existing building was erected last week. This was a requirement. Dusty will go over more detail with Principle Christine.
4. When PODS are to be picked up next December organizational planning will have to occur and coordination with Lord & Son during Christmas break or before. This will be disused again as time moves closer.
