- Financial components & location
- Committee refinement good idea and need to explore. Challenging for Marketing & PR. We do
 not have a plan yet and need that before we are able to start the fundraising. The narrative will
 change, and the financial aspects will change> In the past we brought the committee together
 however we all developments being fluid and little time to react. Hard to assign committee
 members with specifics areas of responsibility and tasks due to so many unknowns.
- Principal Decide on best time to bring aboard. Would like to consider face to face interviews.
 Very important to discern how each candidate feels about fundraising. Learn more about their experience and skills as it pertains to fundraising.
- How did they fundraise in the past?
- Speak with the school district once the facility is secured to discern the possibility and interest for DHS becoming a Magnet or Public School. Ask the school district if they would support taking

it back as a district school. Suggested that perhaps we want to present to the district prior to hiring a principal. In the past CEN suggested that the Principal should be brought on board by September 2020.

- Mayor Gary Jarvis recently commented that there is a 50/50 chance that the school would be
 opened in 2021. When asked why he felt this way he remarked that this is what the community
